II. Executive Summary

The GEF-7 Inclusive Conservation Initiative (ICI) began implementation on February 21, 2022 through a series of virtual Inception Workshops held from February 21 to April 07, 2022. Participants included the ICI Implementing Agencies (IA) and the subproject Executing Agencies (EA). The main objectives of the Inception Workshops were to introduce project partners to one another, familiarize partners with the design and institutional set up of ICI, discuss the Year-1 development of IPLC-led sub-projects that are the principal means through which ICI will operate, and provide an inclusive space to discuss key issues and opportunities, identify synergies with partner organizations and advocate for a truly transformative Initiative that can influence the global conservation community to do more and better when working with IPLCs. Principle outcomes from the workshop include the detailed layout of the roles, support services and complementary responsibilities of the CI-IUCN GEF Project Agencies, PMU and IPLC, the establishment of a safe and inclusive space for IPLC to discuss their expectations and their challenges and to advance their requests, the identification of key synergies within projects, and the commitment to ensure that gender equality, supportive masculinities and generational inclusion are taken into consideration throughout the course of the Initiative

III. Introduction

There is increasing evidence that recognizing Indigenous Peoples' rights is critical to achieving increased ambition from natural climate solutions. The GEF-7 Inclusive Conservation Initiative (ICI) supports IPLC-designed and -led activities that protect biodiversity and result in other global environmental benefits. Supervision and technical guidance are provided by Conservation International (CI) and the International Union for the Conservation of Nature (IUCN), serving as joint GEF Implementing Agencies (IA). Both organizations bring their decades of collective experience working with IPLCs, as well as their regional and global expertise, to the implementation of the GEF Inclusive Conservation Initiative. A concept (Project Information Form) for the Inclusive Conservation Initiative was approved by the GEF Council in December 2019 and the project proposal was endorsed by the GEF in January 2022. The Inception Workshop – an inclusive and staged process that took place between February and April, 2022 - assisted the project team in understanding and taking ownership of the project's objectives and outcomes and detailed the roles, support services and complementary responsibilities of the CI-IUCN GEF Project Agencies, PMU and IPLC Executing Agencies.

IV. Overview of the Inclusive Conservation Initiative

The Inclusive Conservation Initiative (ICI) project aims to support IPLCs to secure and enhance their stewardship over an estimated area of 7.5 million hectares of landscapes, seascapes and/or territories with high biodiversity and irreplaceable ecosystems. ICI will support nine IPLC-led initiatives taking action to address the climate and biodiversity crises in Argentina, Chile, Cook Islands, Democratic Republic of the Congo, Fiji, Guatemala, Kenya, Nepal, Panama, Peru, Tanzania, and Thailand. It will provide resources, enhance capacities, and support 'hands-on' experiential learning that will enable IPLCs to define and demonstrate an inclusive model for conservation where IPLCs are recognized and empowered as decision-makers and key actors at all levels of conservation action, from local action

on the ground, to national policies that impact their rights, to global fora that define conservation and sustainable development targets and approaches for environmental action. Resources approved by the GEF Council include USD 22,535,780 for project activities. The majority of this funding will go to site-based investments, known as Component 1, with smaller amounts devoted to Components 2, 3 and 4 that focus on cross-cutting, global activities.

Component 1. *Local Action to deliver Global Environmental Benefits (GEBs)* – provides direct financial support to IPLC-led initiatives in priority areas that achieve global environmental benefits through improved large-scale management of IPLC lands, territories, and resources.

Component 2. *Global IPLC Capacity Building* – establishes the platforms, peer learning networks and knowledge resources for enhanced IPLC capacity, project and financial management skills, and design of sustainable financing mechanisms.


Component 3. *IPLC Leadership in International Environmental Policy* — enables IPLC representatives to amplify their voices and influence in the international policy decisions that create either enabling or constraining conditions for on-ground inclusive conservation efforts.

Component 4. *Inclusive Conservation Knowledge to Action* – supports IPLC organizations to distill and share knowledge regarding 'inclusive conservation' models to demonstrate large-scale impact and generate support for IPLC-led conservation.


V. ICI Inception Workshops Program

The ICI Inception Workshops Program took place throughout the month of March and the first week of April, 2022 and was a staged process. The Inception Workshop for ICI has two Components, as follows:

- Component 1 Focus on ICI subprojects. This component has 3 stages:
 - Global Subproject Meeting
 - Facilitated Meeting between Subprojects and OFPs
 - Sub-Project Inception Workshop in Country
- Component 2 ICI Global Meeting



VI. Dates



Orientation meetings with ICI subprojects (February 21-25, 2022): These first meetings provided a space for project partners to get to know each other and offered a broad overview of the GEF-Inclusive Conservation Initiative. Participants got to understand the 9 Subproject Concepts and were given a high-level overview of the Subproject planning.

Global sessions (March 02-03, 2022): These sessions focused on subproject planning, with a specific focus on Impact Strategies and M&E, stakeholder engagement and safeguards, budgeting, governance and capacity assessment.

Regional sessions (March 08-09, 2022): The four regional sessions (with East Africa, East Asia, Latin America, and the Pacific) gave the subprojects the opportunity to discuss the preparation of the impact strategies and discussed the stakeholder engagement plan as well as the safeguard mechanisms.

Bilaterals (March 14-30, 2022): The bilateral sessions were conducted to provide the subprojects with a detailed overview of the GEF project cycle and the ICI executing arrangements and allowed the subprojects to discuss stakeholder engagement as well as environmental and social safeguards and funding and budgeting.

Global meeting (April 06-07, 2022): The global sessions provided a space to discuss ICI's opportunities in environmental policy (both in the context of CBD, UNFCCC, UNCCD and Minamata and with other IPLC policy platforms), capacity building and ICI governance and were crucial for identifying synergies with other projects in the region.

VII. Objectives

The objective of the ICI Inception Workshops Program was to bring together the ICI Implementing Agencies (IA) and the subproject Executing Agencies (EA) to:


- ✓ Meet project partners and get to know each other;
- ✓ Provide a broad overview of the GEF-Inclusive Conservation Initiative;
- ✓ Understand the 9 Subproject Concepts;
- ✓ Provide a high-level overview of the subproject planning;
- ✓ Present Component 1 and then Components 2-4;
- ✓ Identify new stakeholders; and
- ✓ Create synergies.

Specifically, the objectives of the different components and stages were to:

- Component 1 Focus on ICI subprojects:
 - Global Subproject Meeting: get to know each other and the overall project, share plans, deeper dive into development of impact strategies, templates, finance, and safeguards, agree on next steps.
 - Facilitated Meeting between Subprojects and OFPs: provide a general introduction with OFP and subproject proponents.
 - Sub-Project Inception Workshop-in Country: engage with local stakeholders and get inputs into the development of subproject impact strategies.
- Component 2 ICI Global Meeting: provide an overview of the project for all stakeholders, subprojects, donors, partners and OFPs, introduce ICI and the 9 subprojects and EA, deeper dive into Components 2-4 to gain further inputs and development, establish project governance at the global level and new synergies.

VIII. Participants

The meetings had over 200 participants from Meso America, South America, Sub-Saharan Africa and Asia-Pacific; and the ICI Team compiled contact information of 105 participants who indicated they want to continue receiving information on the initiative while it is ongoing.

X. Meeting Summaries

A. C1 Global: March 2-3, 2022




During the first day, the ICI team and the project partners introduced themselves and got to know each other. GEF's Sarah Wyatt provided an overview of the GEF, with a specific focus on the different types of projects and the role of the Indigenous Peoples Advisory Group (IPAG). Following this presentation, the ICI team proceeded to provide an overview of the Inclusive

Conservation Initiative, focusing on the context and objectives, the project components and outcomes, the institutional arrangements, and the preparation process. The second day was dedicated to the introduction of the different subproject initiatives, with overviews of each project partner and subproject concept from ANAPAC (DRC Congo), FENAMAD (Peru), NEFIN (Nepal), IMPACT (Kenya), Futa Mawiza (Chile-Argentina), IPF (Thailand), UCRT (Tanzania) and Sotz'il. Both sessions closed with a spiritual invocation and a review of the next steps.

Subprojects highlighted how important it is for the global conservation community to do more and better when working with IPLCs and how ICI is a transformative opportunity to influence global institutions and processes. They also reflected on the IPLC's ability to work with and/or via the support of national governments and agreed on the fact that taking

gender equality, supportive masculinities and generational inclusion into consideration will be key to the success of ICI.

B. C1 Regional: March 7-11, 2022




The four regional sessions (with East Africa, East Asia, Latin America, and the Pacific) opened with an overview of the GEF project cycle (ProDoc and GEF policies) and of the ICI executing arrangements (governance, roles & responsibilities). The ICI team and the participants then moved to discuss the preparation of the impact strategies and then moved to discuss the stakeholder

engagement plan. Importance was given to describing safeguard mechanisms – both the Environmental and Social Monitoring Plan (ESMP) and the Gender Mainstreaming Plan (GMP), with a specific focus on the grievance mechanism. The ICI team also proceeded to review the ICI customs Indicators, cultural Indicators, subproject M&E plans, M&E Roles and responsibilities and then focused on funding and budgeting, with a specific focus on due diligence and preparatory funds. The sessions closed with reflections from the partners and with a review of the next steps.

Subprojects raised the issue of making GEF compliance and accountability accessible and less burdensome and stressed that IPLCs will bring their own innovations to processes and FPIC. They also agreed on the importance of using resources in the impact strategy development phase to be able to hire local consultant support.

C. C1 Bilaterals: March 14-30, 2022

The ICI team met bilaterally with ANAPAC (DRC) Congo and the House of Lau & House Ariki (Fiji & Cooks Islands) to provide them with an overview of the GEF project cycle (ProDoc and GEF policies) and of the ICI executing arrangements (governance, roles & responsibilities) and to




discuss stakeholder engagement, environmental and social safeguards as well as gender. The

meetings also discussed funding and budgeting (due diligence and preparatory finds) and reviewed the next steps.

Subprojects agreed that working with consortiums will offer the capacity for technical support (such as for safeguards) and that working directly with communities without necessarily relying on national pathways is a welcome concept.


D. C2-4 Global: April 6-7, 2022



After an overview of the ICI, participants split into breakout rooms to discuss ICI's opportunities in environmental policy (both in the context of CBD, UNFCCC, UNCCD and Minamata and with other IPLC policy platforms); how to support capacity building of IPLC organizations within and beyond priority geographies; how the ICI Community of Practice will bring together subproject grantees and other organizations and networks working to achieve common ICI goals; and how to enhance the scope of the ICI governance. In the regional breakout rooms participants also identified synergies with other projects in the region and discussed co-financing and global collaboration opportunities. These two sessions concluded the inception process.

Subprojects stressed that ICI can contribute to deconstruct the vertical categorization of different knowledge systems, which sees modern science on top and indigenous Peoples knowledge at the bottom of the hierarchy, and showcase the horizontal existence of the knowledge systems. They also highlighted the challenges they felt right from the process of securing NoL, wished to see more long-term funding projects and highlighted how COVID-19 is still a barrier for in-person collaboration in remote locations. Finally, they identified synergies between ICI and the ICCA Consortium and solicited opportunities for collaboration.

Following the end of the inception process, the global Steering Committee (SC) will lead the governance of ICI. In May the ICI team will conduct bilateral meetings focused on due diligence and from May to October the subprojects will work on the development of their Impact Strategies with the support of the ICI team.

XIII. Closing

The ICI Inception Workshops Program brought together the ICI Implementing Agencies (IA) and the subproject Executing Agencies (EA). Project partners got to know each other, were provided with a broad overview of the GEF-Inclusive Conservation Initiative and the subproject planning and understood the 9 Subproject Concepts. The workshop process has been key for the project team to understand and take ownership of the project's objectives and outcomes and has also detailed the roles, support services and complementary responsibilities of the CI-IUCN GEF Project Agencies, PMU and IPLC Executing Agencies. IPLCs were given a safe and inclusive space to discuss their expectations and their challenges and to advance their requests. They agreed on ICI being a truly transformative opportunity to influence global institutions and processes, discussed their ability to work with and/or via their respective national governments, identified key synergies with other projects and committed to ensuring that gender equality, supportive masculinities and generational inclusion be taken into consideration for the success of ICI.

Resumen

La ICI apoyará nueve iniciativas lideradas por la IPLC que están tomando medidas para hacer frente a la crisis climática y de biodiversidad en Argentina, Chile, Islas Cook, República Democrática del Congo, Fiji, Guatemala, Kenia, Nepal, Panamá, Perú, Tanzania y Tailandia. La Iniciativa de Conservación Inclusiva apoyará la mejora de la administración indígena y comunitaria en 7,5 millones de hectáreas de paisajes terrestres, marinos y territoriales con gran biodiversidad y ecosistemas irremplazables. Reconociendo el papel histórico que siguen desempeñando los pueblos indígenas y las comunidades locales en la salvaguarda de los ecosistemas naturales. El proyecto incluye componentes globales para fortalecer el liderazgo indígena y comunitario en la política internacional, construir acciones basadas en el conocimiento y apoyar el desarrollo de capacidades.



- 1. Identification and documentation of ACPAs in the three major biocultural landscapes in DRC.
- 2. Capacity building of indigenous peoples' institutions and local communities in the governance and management of 47 typical ACPAs in the three bio-cultural landscapes considered
- 3. Strengthening the resilience of ACPA custodian communities to various threats to ACPAs,
- 4. Identification and monitoring of appropriate and effective options for the legal recognition and securing of ACPAs in DRC.
- 5. Inform and advocate for the legal recognition of ACPAs in the DRC
- 6. Development of local economic activities to support part of the costs of conservation.

What is the expected outcome of the Project

- 1. 47 ACPAs supported, including 30 newly identified and documented through the project,








- 1. Life territories strengthened with their boundaries identified and demarcated.
- 2. Ecosystems and their biodiversity are effectively protected and conserved in indigenous territories.
- 3. Improved management and management of the territories and the conservation of their biodiversity.
- 4. Self-management processes of indigenous peoples better organized as active partners in the definition of conservation policies for their territories with natural protected areas.
- 5. Indigenous peoples more resilient and secure in the face of environmental, climate and health crises.

What are the expected results

- 6. Protection of the lives and territories of the peoples in isolation in Madre de Dios strengthened.
- 7. Strategies for the protection of defenders and women strengthened.
- 8. Indigenous peoples and organizations have a positive impact on national and international environmental and human rights agendas and policies.
- 9. Long-term self-sustainability of the protection and management of territories and diversification of actions at various levels.
- 10. Transparent and efficient administration and management of projects with participation of partner organizations.








What do we plan to do in the Futa Mawiza initiative?



DIMENSION

1. Territorial analysis and planning to strengthen the management and governance of the *Futa Mawiza* Biocultural Territory.

ACTIVITIES

- 1. Participatory **cultural mapping** of the territory (Mapuche cultural cartography) reflecting the Mapuche cosmovision, threats and spaces of cultural importance (sacred sites).
- 2. Elaboration of **management and** territorial **governance plans**, with differentiated proposals for areas conserved by the communities and those that overlap with areas protected by the states.
- 3. Elaboration of **biocultural community protocols** for the protection of the lof and the Futa Mawiza Territory.
- 2. Strengthening of the küme felen (collective well-being) and of the development priorities of each lof or community and of the Territory.
- 1. Elaboration of **plans and projects for each lof or community** that contribute to the protection of the territory and the *küme felen* (wellbeing) of the communities.
- 2. Investment and implementation of plans and projects prioritized by each community (tourism, ecological production, food sovereignty, inventory and safeguarding of seeds, etc.).
- 3. Development and execution of **projects to strengthen the protection and conservation of the** *Futa Mawiza* **territory** (e.g. tourism network, exchange networks (trafkintu), environmental education, etc.).

3. National and international advocacy for culturally appropriate recognition and support for the Futa Mawiza Biocultural Territory (years 2 to 5).

- **1. Dialogues** with political authorities and state agencies (Conaf, MMA, regional governments, municipalities, among others) to present and discuss community and territorial proposals.
- **2. Agreements** with scientific and university entities for the development and support of biodiversity and climate change projects.
- 3. Elaboration and implementation of a **communication strategy** for the protection of the Territory.
- 4. Development of regulatory and public policy proposals.
- 5. Development of tools and proposals for national and international advocacy on indigenous rights and participation in national and international forums, particularly in relation to the CBD and the UNFCCC.






CROSS-SECTIONAL DIMENSIONS OR PILLARS

4. Rescue and exchange of knowledge and practices of the Mapuche people for the protection of the territory.

This is done through different ceremonies called *gellipun* and different *txawün* (meetings) where, in addition to the **rescue and exchange**, it will be decided which knowledge will be kept internally and which will be disseminated and shared with others, through different media (audiovisuals, publications, presentations, among others). Women's knowledge and practices (lamgen) and their importance for biodiversity conservation (itxofilmogen) will also be addressed.

5. Strengthening of Mapuche traditional authorities and territorial leaders for better territorial management and governance and the exercise of rights.

It is proposed to create a **school for the transmission of knowledge**, with training cycles that will address different topics previously prioritized by the organizations and communities, specifically addressing gender equity criteria. The school will operate at least during the entire project execution period and among its objectives will be to train at least one person per community in project management and financial resource management. At the end of the project, the organizations involved will be better prepared to manage and administer their own projects.



Expected results after execution of *Futa Mawiza*

The project will mainly support the self-determination process of the *lof* (communities) that make up the Biocultural Territory united by *Futa Mawiza* (large forested mountain) and the creation of a *Mapuche* governance body that will allow for the continuity of this initiative over time, as well as an autonomous and planned definition of economic alternatives in our communities.











Strengthening traditional governance for effective management of natural resources and increased resilience to climate change in Fiji and Cook Island

Who we are

- The **Vanua o Lau** is the formal association of the traditional chiefs of Lau, representing 30 inhabited Islands and their 9,600 inhabitants. This body of chiefs holds the customary authority to make decisions regarding its indigenous population.
- The **House of Ariki (HoA)** consists of ten chiefs and was intended to confer additional legitimacy and strength to the newly self-governing nation, and to help it define its national identity. The Ariki and their tribes are the backbone of Cook Island society.
- Conservation International (CI) is an not-for-profit organization that has worked in the Pacific Islands region since 2002. In the Pacific, CI works with national and local governments, indigenous peoples and communities to conserve their natural heritage. CI empowers societies to responsibly and sustainably care for nature, our global biodiversity, for the well-being of humanity

The Cook Islands and Fiji's Lau Seascape

Cook Islands:


- Consists of fifteen islands spread over roughly 1.9 million km2 of ocean with a population of roughly 17,379 people
- Land area of roughly 236.7 km², representing less than 1% of its Exclusive Economic Zone (EEZ), 62% of the Cook Island's terrestrial landmass is forested (Cook Islands, 2018).
- The size of each island varies and hosts plants, animals and micro-organisms that are critical to the continuing health and survival of each island's biodiversity and the people who rely on these resources for their survival.
- The marine biodiversity of the Cook Islands is globally exceptional, home to seabirds, pristine coral reefs, coastal and lagoon habitats, and a range of migratory species including sharks and whales.
- To conserve these remarkable resources, the Parliament of the Cook Islands passed the EEZ-scale Marae Moana Marine Park, created in 2017, with roughly 324,000 km2 earmarked for higher levels of protection, making it the largest multiple-use marine protected area in the world at the time of its passage.

Fiji's Lau Seascape:

- The Lau Seascape encompasses roughly 26% of Fiji's EEZ, at an estimated 335,000 km2, and is Fiji's most remote archipelago among its constellation of islands.
- Lau contains a wealth of undescribed species and stunning ecosystems that provide food, cultural value, and livelihoods for its 9,600 indigenous inhabitants. Lau is renowned for its biodiversity significance and has been declared a significant Marine Ecoregions (Heaps, 2005), containing 17 separate areas categorized as Special and Unique Marine Areas (Sykes et al, 2018), as well as encompassing an Ecologically or Biologically Significant Area in its southernmost area.
- Lau is also a hotspot for species richness (Selig et al. 2014; Trebilco et al. 2011; Tittensor, et al. 2010) and species endemism (Selig et al, 2014), housing species nesting and breeding for endemic birds, insects, snakes, green and hawksbill turtles as well as the endemic clam and migratory paths of mega cetaceans.
- The people of Lau also possess a unique cultural identity, linguistic dialect and traditions. Tracing their lineage to both Fiji and Tonga, Lauans represent the nexus between Melanesia and Polynesia.

What is the expected result

- The project will support the House of Ariki and the Vanua o Lau to advance their goals for sustainable resource use and management—including the establishment and management of coastal and offshore MPAs, restoration of degraded areas, and terrestrial protected areas—sustainable economic development, and strengthening of cultural integrity in the face of climate change.
- The project is expected to develop the enabling conditions for sustainable management of the Lau Seascape, encompassing 335,000 km2 of ocean, inclusive of 50,000 km2 of high protection areas within the archipelagic waters of Lau. This project will develop the enabling conditions for management of the Lau Seascape at scale by strengthening traditional governance at community and island level across Lau Province. The project will also assess and identify sustainable financing mechanisms and sources to sustain IPLC activities into the future.
- In the Cook Islands, the project will enable the House of Ariki to engage in and contribute to planning for the Marae Moana Marine Park (1.9 million km2), and specifically strengthen capacity for management of the 50nm / 170 km2 of ocean surrounding each island. These 50nm sanctuary zones will be managed and stewarded by local people, the priority at the heart of the Marae Moana Marine Park. The project will support the House of Ariki to integrate critical cultural considerations, including identification of traditionally and culturally significant sites, within the design of the Marae Moana Marine Park






Our territories/lands

- The territory of life for this project is the Ewaso Ng'iro River Basin in Kenya Rangelands
- L. Olbolosat acts as the Ewaso Nyiro River source, whereas Mt. Kenya is the water tower for the basin
- The basin has different ecological zones from the slopes of Mt Kenya; humid and forested. The basin consists of 92% ASALs ecosystem and drains water to the semi-permanent wetland (Lorian Swamp).
- This is a cradle of biological and cultural diversity has been managed by IP pastoralists for centuries
- The Ewaso Nyiro Ecosystem, a territory of life that supports more than 3.5 million people across ten counties, whose majority are indigenous pastoralists communities.
- Challenges: land degradation, over exploitation of natural resources, climate change and variability, and lack of recognition and support for the role of the pastoralists.

What we plan to do in this project

The purpose of this project is to work with communities to document and seek recognition for the Upper Ewaso Territory River Basin as a Territory of Life, also known as an ICCAs, which is a territory or area conserved by Indigenous peoples and local communities. This process will be guided by the ICCA Consortium's recommended phases of establishing an ICCA. These phases include

- Documenting the presence creation of biocultural maps; intergenerational and gender dialogues by IPs elders
- 2. Declaration & legal empowerment support communities to attain legal recognition of their lands and territories by the national and international authorities
- **3. Management plans** support the IPs aspirations for the governance and management of lands and natural resources along the Ewaso Ng'iro Basin
- **4. Monitoring and evaluation** support the communities in monitoring the progress towards the measurable objectives outlined in the management plans
- **5. Community self strengthening, communication & advocacy** creation of knowledge hubs and a physical center to ensure the knowledge flow from one generation to another about the ICCA

What is the expected result?










Map of the proposed geographic area

- 3. Promote sustainable, participatory, just and **responsible natural resource management practices**, REDD+ and biodiversity conservation ensuring gender and social inclusion in the ACA;
- 4. Develop IPLC-based **green enterprises and scope PES (Payment for Environment Services)** and or biodiversity financing mechanisms to strengthen financial and economic sustainability of IPLC in the ACA;

- 5. Promote **nature-and culture-based** solutions to build IPLC's and ecosystems climate resilience generating mitigation **co-benefits** and building on local, traditional and indigenous knowledge in the ACA;



- UCRT aims at Improving the lives of pastoralist, agro-pastoralist, and hunter-gatherer communities in northern Tanzania by empowering them to sustainably manage and benefit from the natural resources on which their livelihoods depend. UCRT does this through its focus in 5 thematic areas:
- i) Community Land Tenure
- ii) Governance
- Iii) Community Natural Resource Management
- Iv) Nature Based Livelihoods
- V) Social Empowerment
- UCRT has championed local land rights for indigenous groups and have been able to secure 1.2m Ha of land through the CCRO legal mechanism.
- UCRT's success was recognized as early as 2008, when the United Nations Development Programme selected UCRT to receive the prestigious <u>Equator Prize</u> in recognition of contributions to conservation and development in Tanzania. Then in 2016, Edward Loure was awarded the Goldman Environmental Prize for achievements and leadership of UCRTs grassroots environmental activism (https://www.goldmanprize.org/recipient/edward-loure/).






Our territories/lands

- The Northern Tanzania rangelands represent a globally significant ecological system that supports a rich diversity of wildlife and people, including the Akie, Datoga, Hadzabe, Iraqw, and Maasai.
- This savanna landscape provides a vital function for wildlife, while remaining integral to the livelihoods and cultures of indigenous groups.
- Broadly speaking, the project area extends across critical areas of rangeland connectivity south and east of the greater Serengeti – Ngorongoro and make up the northern and southern most extents of the Tarangire – Manyara ecosystems.
- This area is most known for its extensive wildlife migrations including over 4,000 elephants and around 20,000 zebra and 20,000 wildebeest.
- Beyond these large mammal attractions, the area maintains several diverse ecological features, including three large soda lakes, afro-montane forests atop Great Rift valley volcanic mountains, short grass plains and seasonal wetlands, dense woodlands and acacia forests, and riverine systems.

What we plan to do in this project

- Raise community awareness and engagement on land laws and policies governing land and natural resources.
- Facilitate 14 CVLs, 18 Village LUPs (VLUPs) and 14 communal CCROs
- Monitor and evaluate adherence to VLUPs, CCROs, and natural resource governing by-laws in the villages
- Train and coach village councils and natural resource committees responsible for managing rangeland and forest resources
- Facilitate establishment, training and coaching of multi-village rangeland committees and link them to District and National level Rangeland Councils

- Train and coach village councils and CBO's (e.g., Makame WMA, EECDI, Lake Eyasi Cultural Tourism Board) in management and use of community funds.
- Train and coach savings and credit groups targeting women and youth.
- Develop sustainable natural resource-based income generating activities (e.g., beekeeping, traditional medicine, livestock fattening)
- Train and coach WRLFs, youth, and traditional leaders in land and natural resource management to improve broad community engagement and inclusion in decision-making.
- Equip and train village grazing coordinators and community natural resource monitors responsible for ecological monitoring, protection, and enforcement of agreed plans and by-laws.



- For GEF-7, recognition that IPs should be receiving more and larger funding for their role in protecting the global environment.
